GALAX CITY COUNCIL MEETING Minutes November 26, 2001

The Galax City Council convened in regular session on November 2, 2001, in the courtroom of the W. Harold Snead Public Safety Building. The meeting was called to order by the mayor at 7:35 p.m. with the following councilmen present and they are as listed: C. M. Mitchell, Glenn Wilson, Odell Hamden, Van McCarter, George Valdez, and Willie Greene. Johnny Lemons was absent from the meeting.

Councilman Wilson motioned to approve the minutes from the last meeting and to dispense with the reading. Councilman McCarter seconded the motion and it was unanimously approved.

City Manager Campbell reviewed the Downtown Planning Study. Following discussion, Councilman Hamden motioned to proceed with the study. Councilman McCarter offered a second to the motion and it was unanimously approved.

Dr. Alexander from Wytheville Community College was present at tonight's meeting to discuss a proposed project **Crossroads Rural Entrepreneurial Institute** which is an educational and economic development collaboration on a regional level.

Mr.Tom Taylor from Mt. Rogers Planning District Commission was present at tonight's meeting to review and ask approval of three Resolutions. Councilman Wilson motioned to support the resolution Rural Prosperity. Councilman McCarter seconded the motion and it was unanimously approved. Following discussion, Councilman Hamden motioned to delay approval on the Tax Reform resolution until more information is reviewed. Councilman McCarter seconded the motion and it was unanimously approved. Councilman Wilson motioned to approve the Tobacco Commission resolution. Councilman Hamden offered a second to the motion and it was unanimously approved.

Dave Nelson, director of Parks and Recreation, was present at this meeting to discuss a survey and facilities study to be conducted for the recreation department. The cost of this work is covered in this year's budget.

City Attorney Ward requested emergency approval of two ordinances. The first ordinance is to jointly establish a Regional Law Library with Grayson County at the Courthouse in Independence. Councilman Wilson motioned to approve said ordinance. Councilman McCarter seconded the motion. Councilmen Mitchell, Wilson, McCarter, Greene and Valdez each offered a yea vote. Councilman Hamden abstained.

The second proposed ordinance was to amend the current ordinance for assessing a \$2.00 fee on each civil case heard in the Galax General District Court. These fees would be used to maintain a

law library at the Courthouse in Independence. Councilman Wilson motioned to accept the ordinance as presented. Councilman McCarter seconded the motion. Councilmen Mitchell, Wilson, McCarter, Greene and Valdez each voted yea. Councilman Hamden abstained.

Councilman Wilson motioned to accept the state holiday schedule for city employees. Councilman McCarter seconded the motion and it was unanimously approved.

At 9:10 pm Councilman Hamden motioned to go into executive session as authorized in the Code of Virginia Section 2.1-344(A)(7) to discuss legal matters. Councilman Wilson seconded the motion and it was unanimously approved.

Councilman McCarter motioned to return to regular session. Councilman Hamdenseconded the motion and it was unanimously approved.

The Certification of Executive Session is made a part of these minutes.

With no other business to come before Council, the meeting was unanimously adjourned at9:30 pm on a motion by Councilman Wilson.
