

CITY OF GALAX DELINQUENT REAL ESTATE TAX LIST FOR 2016 AND PRIOR YEARS

Properties listed with bankruptcy petitions include only those amounts coming due within one year prior to the filing of the bankruptcy petition. Failure to pay all amounts due by September 1, 2017 may result in additional efforts to collect amounts due to the City of Galax up to and including proceedings to sell the described parcels as authorized by Virginia Code 58.1-3965, et seq., 1950, as amended.
